

VILLAGE OF ELNORA

BYLAW NUMBER 497-0809

Being a Bylaw to Amend The Cat Control Bylaw Number 492-0804

WHEREAS the Council of the Village Of Elnora, in the Province of Alberta, deem it necessary to amend the Village Of Elnora Cat Control Bylaw Number 492-0804, to provide for a clearer understand and enforceability of the Bylaw.

NOW THEREFORE the Council of the Village Of Elnora, in the Province of Alberta in open meeting assembled enacts as follows:

1. THAT No. 2 (b) be amended as follows: by deleting the last sentenced. “A Bylaw Enforcement Officer is a Designated Officer.”
2. THAT No. 2 (f) be amended as follows: by deleting the words “during any continuous period in excess of twenty-four (24) hours.
3. THAT No. 15 be amended as follows: by replacing the word “shall” with the word “may”.
4. THAT No. 20 be amended as follows: by replacing the first sentence with the following “The Bylaw Enforcement Officer, Contractor, or Pound keeper shall report any apparent illness, communicable disease, injury, or unhealthy condition of any Cat to a veterinarian and act upon his recommendation”.
5. THAT No. 29 be amended as follows: by replacing the words “of Competent Jurisdiction” with the words “the Provincial Court”.
6. THAT No. 30 be amended as follows: by deleting in its entirety and replacing with “The Violation Ticket shall be served upon the person who is believed to be responsible for the contravention under the Bylaw in accordance with the provisions of the Provincial Offences Procedures Act. RSA 2000c P-34 as amended.
7. THAT GENERAL SECTION No. 33 and 34 be amended as follows: by deleting in its entirety.
8. THAT SCHEDULE “A” PENALTIES be amended by deleting in its entirety and replaced with the following:
